1.1 The Board interviewed Ms. Elvira B. Lapuz, the lone nominee for the University Librarian position of UP Diliman.

1.2 After a short deliberation, the Board approved the appointment of Ms. Elvira B. Lapuz as University Librarian of UP Diliman, effective 26 October 2023.

- b.1** Regent Ramota moved for the approval of the appointments of the UPLB Vice Chancellors, effective 01 November 2023 to serve at the pleasure of the Chancellor. Regent Belegal seconded the motion. There being no objections, the same were approved.

- 2.1** UP Los Baños Chancellor Jose V. Camacho, Jr. presented the proposal to rename the selected facilities of the UP Los Baños Francisco O. Santos Hall (Physical Sciences Building) in honor of the three (3) pioneers of the Computer Science program in UP Los Baños during the time of President Emil Javier.

- 2.2** After the confirmation by Chancellor Camacho that the renaming went through the regular process, Regent Belegal moved for the approval of the proposal. Regents Trinidad and Ramota seconded the motion, and there being no objections, the same was approved.

**1. Establishment of the UP Manila Science and Technology Park (STP) at the New Clark City (NCC), Tarlac**

- 1.1 Vice President for Academic Affairs Leo Cubillan, together with UP Manila Chancellor Carmencita Padilla and Vice Chancellor Edward Wang, presented the proposal for the establishment of the UP Manila Science and Technology Park (UPM-STP) at the New Clark City (NCC), Tarlac, including the background of the project and the challenges and gaps in the technology translation cycle. President Jimenez added that the rationale of the proposal is for the research outputs to reach and benefit the Filipino people.
- 1.2 Chancellor Padilla narrated that the idea of a Science and Technology Park came after the strategic planning of UP Manila's National Institutes of Health (NIH) when they realized that there is a big gap in scaling up research discoveries due to a lack of facilities. This led them to research possible solutions here and abroad, and to benchmark with leading universities abroad.
- 1.3 Vice President Cubillan added that the vision of the UP Manila STP is to contribute to the macroeconomy by becoming a prime mover of health and technology innovation, translation, commercialization, and human capital development by 2030, with a mission to provide the science community and industry an inclusive and collaborative ecosystem that fuels groundbreaking research, empowers visionary entrepreneurs, and supports the country's macroeconomy. He stated that the UPM-STP proposal is aligned with the Philippine's National Innovation Agenda and the Philippine Innovation Act (RA 11293).
- 1.4 Vice President Cubillan further explained that a Science and Technology Park is an organization managed by specialized professionals that aims to increase the wealth of its community by promoting a culture of innovation and the competitiveness of its associated businesses and knowledge-based institutions. In the Philippines, he said that there is no recognized Science and Technology Park because it requires an entire ecosystem of

innovation hubs. A perfect example of a successful STP is the Singapore Biopolis which is a model of biomedical research and biomedical sciences and is considered as a driver of the economy of Singapore.

- 1.5 In terms of management of STP, Vice President Cubillan presented the Quintohelix Innovation Model, which is the successful model being used by STPs around the world. Under this model, the UP Manila will serve as the academic pillar of the STP.
- 1.6 Regent Pastorfide inquired about the economic aspect of the proposal, specifically the finances involved, and the reason for choosing the NCC as development site for the UPM-STP. Vice President Cubillan responded that the NCC is the perfect location to set up an STP as it is designed as a comprehensive city with access to air, sea, land, and high-speed transportation from and to Metro Manila. It is also identified as the future alternate city for Metro Manila where government offices will be built and developed. He mentioned that the Philippine General Hospital (UPM-PGH) is expected to operate its polyclinic within the year at NCC. President Jimenez added that once the BOR approves the concept proposal, the proponents could proceed with the next phase including financial requirements.
- 1.7 Regent Pagdanganan remarked that the UPM-STP concept is commendable. When informed that the lease contract for a similar project, the UP-Ayala Technohub, is expiring in a few years, he suggested studying exit strategies for such projects. He also recommended that the Vice President for Development and the Vice President for Planning and Finance be at the forefront of the UPM-STP project. Vice President Balmores reported that she is already working closely with the proponents of the project.

President Jimenez likewise advised that there are plans for future Vice Presidents to work on this project as a UP System project.

- 1.8 Regent Ramota inquired on the governance structure, staffing requirements, budget and operations, and the relationships with the national and local government units for this project. Chancellor Padilla replied the UPM- STP will be at the same level as PGH and NIH and will be funded through earnings from royalties and rentals. She also cited the experience of the UP Philippine Genome Center which also started as a concept.
- 1.9 Regent Trinidad suggested including specific goals for the different sectors of the UP community while Regent Aranton suggested consulting with the Philippine Economic Zone Authority (PEZA) especially on the concept of the science park. President Jimenez replied in the affirmative and added that they are already collaborating with the Department of Trade and Industry through the support of former UP President and now DTI Secretary Alfredo Pascual.
- 1.10 After further discussions, Regent Pagdanganan moved for the approval of the establishment of the UP Manila Science and Technology Park at the New Clark City in Tarlac. Regent Aranton seconded the motion. There being no objections, the same was approved.

#### **1. Reprogramming of UP System Administration's Unexpended Balances of Prior Years' Obligations to fund MOOE and EO/CO Projects in the amount of P60,868,000.00**

- 1.1 Vice President Balmores gave a brief background of the reprogramming request of UP System's unexpended balances of prior years' obligations in the total amount of P60,868,000.00 to fund the financial requirements of UP Cebu's SheShelter Residences and the augmentation of UP System's International Linkages Fund (ILF) with corresponding amounts of P40,868,000.00 and P20,000,000.00, respectively.
- 1.2 UP Cebu Chancellor Leo B. Malagar presented the funding requirements for the construction of the UP Cebu SheShelter Residences, which is a three-storey ladies' dormitory with a roof deck. He explained that the proposed student housing aims to address the increasing demands for on-campus housing and to improve the educational opportunities for female students. He also showed the pertinent data on student housing which shows the gap between the demand based on applications and the current capacity of existing dormitories.
- 1.3 Regent Pagdanganan recalled that during the BOR Finance Committee meeting held on 23 October 2023, Chancellor Malagar mentioned that there is a P2 Million donation by a non-government organization for the proposed student dormitory, subject to a request for naming rights. In response, Chancellor Malagar clarified that the construction of the dormitory will require a total of P42,868,000.00, but due to a donation of about P2 Million by a non-government organization and foreign aid, UP Cebu is only requesting a budget of P40,868,000.00.

- 1.4 Regent Pagdanganan pointed out that UP Cebu must ensure that the amount of donation is substantial enough to merit naming rights. President Jimenez reminded the body that under the university's rules, the naming rights for UP properties may be granted only if the donation amounts to at least 50% of the project cost/value, and even then would still require BOR approval. Chancellor Malagar assumed the task of explaining to the donor why it could not be given naming rights in light of the university's rules.
- 1.5 Regent Belegal raised safety and security concerns regarding the plan of having a roof deck on ladies' dormitory, to which Chancellor Malagar replied that they will ensure that the architectural design is compliant with existing safety and security standards.
- 1.6 There being no further clarifications and questions, Regent Tiongco moved for the approval of the reprogramming request of UP Cebu amounting to P40,868,000.00. Regent Aranton seconded the motion. There being no objections, the same was approved.
- 1.7 On the request of the UP System for the augmentation of the International Linkages Fund (ILF), Vice President Balmores presented the request for the reprogramming of P20,000,000.00 to augment the ILF which is used for the foreign travel of the Office of the President and other UP System Administration offices, including at times, the Constituent Universities and the

UP Symphony Orchestra (UPSO). In this light, President Jimenez recognized the goodwill created by the UPSO for the University, especially during the ASEAN-China cultural week, which resulted to repeated invitations. He then suggested arranging a tour for UPSO in the United States with an exhibit of Philippine arts to project a positive image for the University, attract academic partnerships, and expose the Filipino children in the US to the Filipino culture.

- 1.8 After further discussions, Regent Pagdanganan moved for the approval of the augmentation of the ILF amounting to P20,000,000.00, subject to the usual documentation in compliance with auditing rules and regulations. There being no objections to the motion duly made, the same was approved.

- 2.2 Chancellor Vistan further explained that the requests are mostly to support the hyflex teaching and learning modality, as well as student support services such as the renovation of student residence halls and support offices.
- 2.3 President Jimenez pointed out the need for maintenance and upkeep of buildings and facilities. Regent Pagdanganan agreed that a system for preventive maintenance of buildings and other facilities should be put in place in the University. Chancellor Vistan shared that in UP Diliman, property management and ground maintenance operations are currently decentralized to the colleges and units. He added, however, that they are considering having an office that will manage properties.
- 2.4 Regent Pagdanganan moved for the approval of the reprogramming request of UP Diliman. There being no objections to the motion duly made and seconded, the request was approved.

Revolving Fund amounting to a total of P50,162,000.00, which is divided into Personnel Services (PS) in the amount of P750,000.00; Maintenance and Other Operating Expenses (MOOE) in the amount of P39,412,000.00; and the Futures Thinking Project in the amount of P10,000,000.00. She also explained in detail the intended use of each funding category.

3.2 Given that Chancellor Padilla's term is ending on 31 October 2023, Regent Pagdanganan inquired on whether the reprogramming request is supported by Chancellor-elect Michael Tee so as not to put in peril the payroll of job order employees. In response, Chancellor Padilla assured the Board that Chancellor Tee supports the request and was present earlier in the meeting via Zoom but was cut-off due to poor internet connection. She said, however, that she will defer to the decision of the Board and allow the incoming Chancellor to determine how to fund the payroll in the meantime.

3.3 After further discussions on the timelines and on the possible effects of the delay in approval, Regent Pagdanganan moved for the approval of the request of UP Manila to reprogram its savings. Regent Belegal seconded the motion, and there being no objections, the same was approved.

4.1 UP Manila-Philippine General Hospital (PGH) Director Gerardo D. Legaspi presented the request for the programming of UP-PGH's unprogrammed income in FY 2022, in the total amount of P52,387,000.00, which will be used for the Service Recognition Pay of retiring employees, the cost of strengthening PGH's cybersecurity, and equipment for Human Resources Information System and Information Technology network.

4.2 Upon inquiry of Regent Pagdanganan, Director Legaspi explained that the unprogrammed income are funds collected from the various services rendered by PGH. Regent Pagdanganan then referred to such income as total gross receipts minus the disbursements.

4.3 Regent Ramota requested an update on the request of the academic union of UP Manila for the release of the agency fee for the CNA Incentives for fiscal years 2021 and 2022. In response, Director Legaspi said that he will take it up first with the PGH Budget Officer and provide an update to Regent Ramota.

4.4 With no further questions, Regent Pagdanganan moved for the approval of UPM-PGH's request for programming of its unprogrammed income in FY2022. Regent Tiongco seconded the motion. There being no objections, the same was approved.

- 5.1 Vice President Iryn Balmores presented the proposal for the creation of the Sports and Varsity Programs Revolving Fund, which will be used and monitored by the UP Office for Athletics and Sports Development (OASD) and managed by the UP System. She enumerated the sources of funds, including but not limited to the UP's share in University Athletics Association of the Philippines' (UAAP's) fees, collections from grants and donations, income generated through outputs, sponsorships, payment for the use of facilities, among others.
- 5.2 Vice President Balmores further explained the proposed utilization of the fund which will primarily be for the support of student-athletes, varsity coaches, OASD staff, training and team development, and other operational requirements.
- 5.3 Regent Pagdanganan expressed support for the creation of the Sports and Varsity Programs Revolving Fund and moved for the approval of the same, subject to the creation of a mechanism for making petty cash funds available to coaches, or duly authorized personnel, for emergency purposes. Vice President Balmores responded in the affirmative and added that a cash advance facility may be set up for the coaches or OASD personnel that will be subject to liquidation in accordance with the usual accounting and auditing laws, rules, and regulations.
- 5.4 Regent Tiongco moved for the approval of the creation of the Sports and Varsity Programs Revolving Fund. Regent Belegal seconded the motion. There being no objections, the same was approved.

**6. Increase in economic benefits for regular personnel in the amount of P1,500.00 per qualified UP employee**

6.1 Vice President for Administration Augustus Resurreccion presented the proposal to increase the economic benefits for regular personnel in the total amount of P1,500.00, distributed to the three economic benefits currently being given to regular personnel, as follows: P300-increase in the Annual Incentive Grant (AIG), from P13,700.00 to P14,000.00; P600-increase in the Christmas Grocery Allowance, from P8,400.00 to P9,000.00; and P600-increase in the Rice Subsidy, from P9,400.00 to P10,000.00. He added that the legal basis for the increase is provided for under the UP Charter and the Collective Negotiation Agreement (CNA) between the University and the two Unions. He clarified that the proposal will be effective for FY 2024.

- a. Regent Pagdanganan pointed out that the increase is only about 4.8%, which is lower than the current inflation rate. He then moved for the approval of the proposed increase. Regents Tiongco and Belegal seconded the motion. There being no objections, the proposed P1,500.00 increase in economic benefits was approved.
- b. Regent Belegal requested if it is possible to apply the increase for the Christmas Grocery Allowance which will be granted in December. Regent Ramota clarified that the request is to apply the newly approved P600-increase to the 2023 Christmas Grocery Allowance; thus, granting the amount of P9,000.00 instead of the current amount of P8,400.00.

##### **4. Report on the Marine Science Institute (MSI) Marine Station**

- 4.1 The UP Diliman Marine Science Institute (MSI) team headed by College of Science Dean Giovanni Tapang, MSI Director Prof. Laura David, and MSI former Director Prof. Fernando Siringan presented the developments of their research work in the West Philippines Sea. For this purpose, the MSI research team travelled to the Kalayaan Island Group aboard the university's research vessel, the MV Panata. They confirmed the highly productive food resources of the West Philippines Sea's, and were able to document 33 new species of seaweeds, including the red algae *Griffithsia* which may be used in the production of anti-HIV drugs.
- 4.2 With the indulgence of the Board, Prof. Siringan introduced the MSI team of marine scientists and researchers who were in Pag-asa Island led by Dr. Cesar Villanoy, Dr. Irene Rodriguez, and Dr. Caroline Marie Jaraula. The team also informed the Board that the MSI has a small research station on Pag-asa Island called the Pag-asa Island Research Station (PIRS), which also doubles as the dormitory and laboratory of the marine scientists and researchers. They then asked the support of the Board for the construction of a proper dormitory for the marine scientists and researchers in the amount of P20 Million.
- 4.3 After further discussions, President Jimenez instructed Prof. Siringan to submit the proposal to the Office of the President, including the financial requirements. He added that he will study the proposal first and bring it up to the Board once ready.
